Data Protection Privacy Notice

In the course of completing this Consent Form, you have provided information about yourself ('personal data'). We (the University of Oxford) are the 'data controller' for this information, which means we decide how to use it and are responsible for looking after it in accordance with the General Data Protection Regulation and associated data protection legislation.

How we use your data

We will use your data for the Purposes as set out in this Consent Form. We are processing your data for these purposes only because you have given us your consent to do so, by signing this Consent Form.

Who has access to your data?
